# COACHING BY BEAUTY

## CLIENT CONTRACT

**This agreement is binding.**

<b>SERVICES:</b>	<b>INVOICE AMOUNT: \$1,200.00</b>
<p>Coaching Instruction Services for one (1) individual which constitutes an Hourly Rate of \$100.00 per Coaching Session per weekly 1-hour class, totaling a Monthly Rate of \$400.00 per month and totalling a 3-Month Cycle Rate of \$1,200.00 per lesson cycle. Sessions are scheduled by Instructor and Client upon mutual agreement to a set weekly day and time. Rate good for four (4) Coaching Sessions per 4-week period during any given month. Mandatory 3-Month Lesson Cycles are required under this Client Contract. This Client Contract is binding. Total cost for the 3-Month Lesson Cycle is \$1,200.00 which is invoiced herewith and should be paid in full and upfront.* Payment may also be made in three (3) equal monthly payments of \$400.00 ONLY for Clients in Good Standing.** All payments are made via <b>PayPal</b> to paypal.me/ZMGBeauty or via <b>CashApp</b> to \$beautifulmunoz. Payments are due on the 1st of each month. In essence, each 3-Month Lesson Cycle translates to twelve (12) consecutive weeks of Sessions with Payment being due and payable on the 1st day of the month for the upcoming 1st, 5th and 9th Session. After each contractual 3-Month Lesson Cycle, continuation of Coaching Sessions may proceed by entering into another 3-Month Lesson Cycle Contract with advanced payment (the same above payment terms and conditions apply), and shall continue until terminated by either party ONLY at the completion of the then current 3-Month Lesson Cycle. Lessons may not be terminated mid-cycle. Lessons may only be terminated by either party AFTER the then current 3-Month Cycle is completed. Should Client miss a scheduled Session and thus require rescheduling accommodations, a Make-up Session must be scheduled with the Instructor within five (5) days of the absence, prior to the next weekly scheduled Session. In the event of absences and rescheduling, Payment is still due. Rescheduling after an absence is Client's responsibility. Failure to reschedule will result in the loss of the Session in question. Further, non-attendance does not exempt Payment. Payment is due upfront for Services.
